

TERMS AND CONDITIONS OF USE OF THE SOFT-TRANSPORT LICENSE



This Licensing Agreement is a legal agreement between

The beneficiaries of this application,

for the use of **the software product Soft-Transport**, which includes the software, its database structure, and the associated support services.

DURATION OF THE AGREEMENT

The license granted by this Convention shall begin with payment of the software right to use (its price according to the chosen plan), and shall expire at the end of the period for which the license was acquired.

The duration of the license may not be less than 1 month.

In the case of successive renewals of the license, this Convention shall be automatically concluded, without any other formality, for the period for which the right to use the software has been paid, but not less than 1 month.

LOCATION OF THE SOFTWARE

The Client understands and accepts that the license is granted for use the software at a specified location (web address) on one of the distributor's servers, in the Ultra-Light, Light and Convenient Plan, respectively on the beneficiary's server in the Standard Plan.

As functionality, the plans differ as follows:

- The Ultra-Light plan does not benefit from the section dedicated to Subcontractors, Auto Service and Driver Shifts.
- The Light Plan does not benefit from the section of Auto Service.

If it is desired to change the purchased plan during the duration of the license agreement with a more expensive plan, this can be achieved by paying the difference in price between the plan already purchased and the desired plan.

The price of the desired plan will be considered the most favorable to the customer among the price displayed on the www.soft-transport.com, at the date of the change or the one in force at the time of purchase of the initial plan, based on the price guarantee.

PRICE GUARANTEE

If the recipient will extend the subscription (license) every year without interruption, they will benefit from the same purchase price of the license. In other words, it will not be affected by a possible price increase.

PRODUCT WARRANTY

The provider of the Soft-Transport software does its best to present as clearly and as extensively as possible the capabilities of the software, before it is purchased.

If the beneficiary is not satisfied with the purchased product, within 30 days from the date of purchase of the license, he may request in writing the termination of the contract and the reimbursement of the value of the license paid.

This request must contain at least a proof of a minimum testing of the application (for example, a screen print) and the reasons for dissatisfaction that generated the request for reimbursement of the value of the application.

The product warranty is valid at the first purchase of a Soft-Transport license.

ASSISTANCE DURING THE CONTRACT PERIOD

The application is distributed "AS IS" ("AS IS"). However, the Distributor provides assistance during the term of the contract as follows:

a. New versions. Euload may, at certain intervals of time, release new versions of the Soft Transport Application, containing corrections to errors and/or Updates. Euload will provide the Client with a copy of the new version at no additional cost for the Ultra-Light, Light, Standard (first 10 years) and Convenient (first 10 years) plans. For standard and convenient plans, after 10 years, the update of the application to the new version will be subject to the annual payment of a *Customer Support Plan and New Versions*, worth 20 euros / month. The installation of the new version is the responsibility of the supplier within a maximum of 7 working days from the date of its launch, for the Ultra-Light, Light and Convenient plans. Euload provides you, on www.soft-transport.com or by email, the latest news regarding the versions of the application.

b. Providing a **user account** on www.soft-transport.com, for the beneficiary of the application through which suggestions can be made and tickets can be opened. Access data (username and password) will be provided by the Provider Customer Support.

c. Implementation manual of the application in PDF format – a guide that we recommend you to have in front of you and follow it when accessing the program, in the first days of implementation!

DATA SECURITY AND CONFIDENTIALITY

The manufacturer undertakes to maintain the confidentiality of the Contact Details of the Beneficiary and of any information regarding his activity, to which he would happen to have access during the performance of this contract.

As the provider of the application we undertake not to disclose, distribute, use in any way the database of the beneficiary, this representing his exclusive property.

The safety of your data is our number 1 priority.

The application offers several security-related facilities:

a). Hosting, in the case of the Ultra-Light, Light and Convenient variant, on high-performance servers, which have ensured daily back-up, and which have implemented anti-fraud policies.

b). The software that runs at the base of the application (PHP, MySQL) is state-of-the-art.

c). The application files are encrypted using our own encryption code. In addition, in the case of the Ultra-Light, Light and Convenient variant, the server is equipped with a positive SSL digital certificate (*Data retrieval is done on 256bits. To decrypt an encryption with 256 bits would take 50 supercomputers that check 10 to the power of 18 , keys per second, and would take 3 x 10 to the power of 51 years, to be able to decrypt the information. Such a super computer has never been fabricated*).

OTHER CLAUSES

a. This Agreement shall be governed by the laws of Romania. Any disputes arising from the interpretation, execution, application or performance of this contract will be resolved amicably, and if this is not successful, it will be within the competence of the courts of Oradea, Romania.
